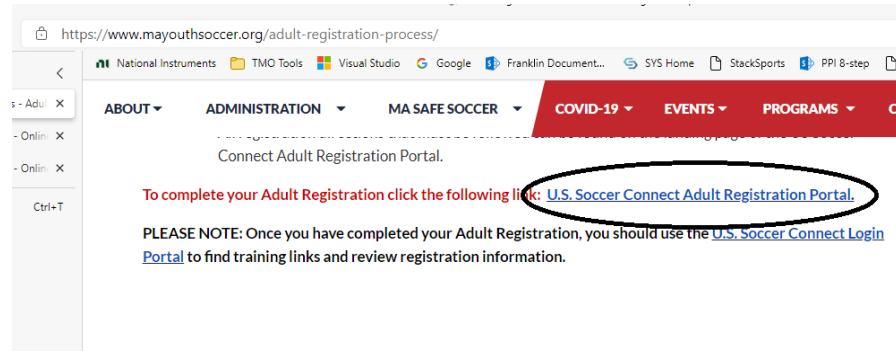

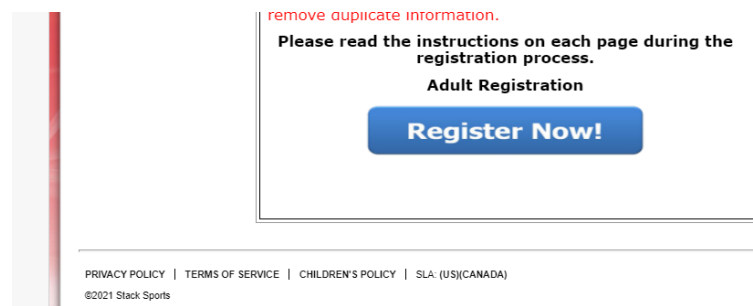

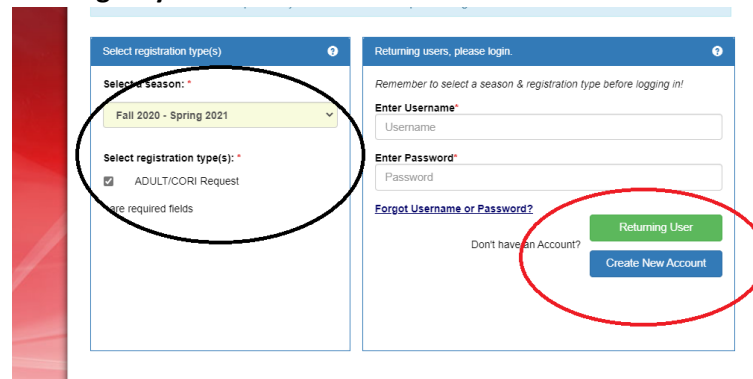
Adult Registration Process

- All registration directions that must be followed can be found on the landing page of the US Soccer Connect Adult Registration Portal.

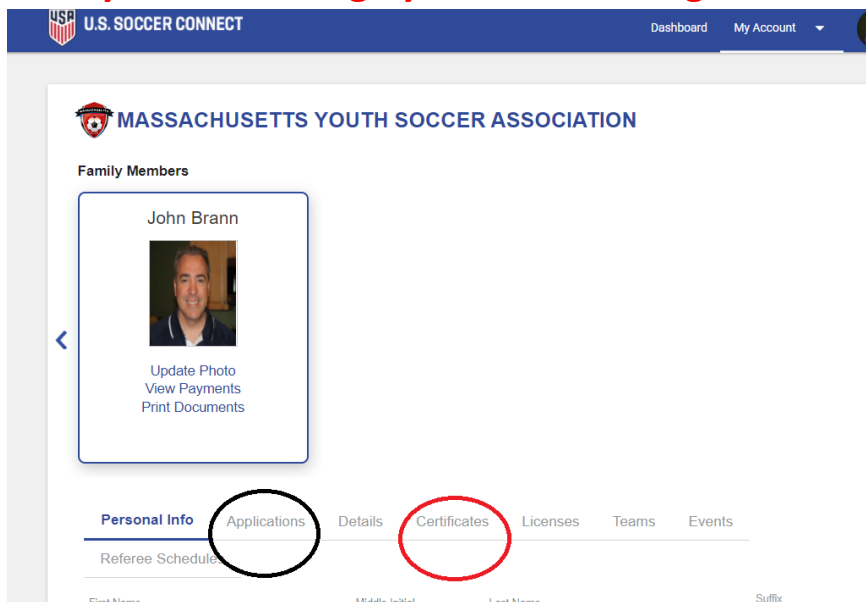

Certificates
If you have available certificates, click on the image to upload or view a file.

If you are under the age of 18, parents should check with your organizations Risk Manager on requirements.

SafeSport Training:
Make sure to create your SafeSport account listing U.S. Soccer as your NGB, and with the same first and last name and email address listed in your adult registration account. There is no need to upload your certificate of completion; although, you should save your SafeSport certificate of completion to your computer as it may be needed later if the auto-approval/verification fails.
Your account should be automatically updated to show your completed training within 24 hours.
If you took the training in 2020, you can upload that Certificate of Completion for your orgs Risk Manager to approve/verify.

Concussion training is through the Centers for Disease Control (CDC) - Concussion Training Information:
As of March 1, 2020, you are unable to use your log in information from last year's course. Concussion training is being administered in a new system called CDC TRAIN; all adults that registered prior to March 1st, will need to establish a new account with a new login and password to access the HEADS UP Youth Sports Training.
The link below will show everyone how to create an account through CDC Train and provide them the link to take the training or login, if the adult already has an active account.
Once training is completed, you are required to return to this Certificate tab and upload the CDC Certificate of Completion.
If training was completed June 1st, 2019 or later, you are approved for the Fall 2020 - Spring 2021 registration year.

NOTE: If your SafeSport, concussion, or CORI Verification show as Verified (you see a check mark), no action is needed from you for this registration year.

CORI Verification (verifying persons legal first and last name and date of birth) is a one-time event while CORI and National background Checks are processed every three years. If you are not CORI Verified, please print your CORI Acknowledgement form and contact your organizations Risk Manager. Do NOT upload your CORI Acknowledgement form, or your government issued photo ID to your account.
